We understand how important it is to keep your personal information safe and secure and we take this very seriously. We have taken steps to make sure your personal information is looked after in the best possible way and we review this regularly.

Please read this privacy notice ('Privacy Notice') carefully, as it contains important information about how we use the personal and healthcare information we collect on your behalf.

1. WHY WE ARE PROVIDING THIS PRIVACY NOTICE

We are required to provide you with this Privacy Notice by Law. It explains how we use the personal and healthcare information we collect, store and hold about you. If you are unclear about how we process or use your personal and healthcare information, or you have any questions about this Privacy Notice or any other issue regarding your personal and healthcare information, then please do contact our **Data Protection Officer** (details below).

The Law says:

- A. We must let you know why we collect personal and healthcare information about you;
- B. We must let you know how we use any personal and/or healthcare information we hold on you;
- C. We need to inform you in respect of what we do with it;
- D. We need to tell you about who we share it with or pass it on to and why; and
- E. We need to let you know how long we can keep it for.

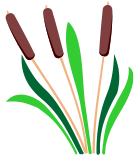
2. THE DATA PROTECTION OFFICER

3. ABOUT US

We, the Bosmere Medical Practice ('**The Practice**') situated at Solent Road, Havant, PO9 1DQ, are a **Data Controller** of your information. This means we are responsible for collecting,

storing and handling your personal and healthcare information when you register with us as a patient.

There may be times where we also process your information. That means we use it for a particular purpose and, therefore, on those occasions we may also be **Data Processors**. The purposes for which we use your information are set out in this Privacy Notice.

4. INFORMATION WE COLLECT FROM YOU

The information we collect from you will include:

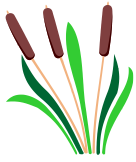
- A. Your contact details (such as your name, telephone number and email address, including place of work and work contact details);
- B. Details and contact numbers of your next of kin;
- C. Your age, gender, ethnicity, language, disability status, information we need to allow us to provide information in a more accessible format to you;
- D. Details in relation to your medical history;
- E. The reason for your visit to the Practice;
- F. Medical notes and details of diagnosis and consultations with our GPs and other health professionals within the practice involved in your direct healthcare.

5. INFORMATION ABOUT YOU FROM OTHERS

We also collect personal information about you when it is sent to us by the following:

- G. Hospitals, consultants or any other medical or healthcare professionals, or any other person involved with your general health- or social care.
- H. Insurance companies –in respect of requests for medical information, with your prior approval
- I. Police service – in respect of a Firearms application you are making
- J. Social Services
- K. Solicitors – correspondence from them about you
- L. Benefit Agency
- M. Driving Vehicle Licensing Authority (DVLA)
- N. Indeed any organisation who you give permission to ask for your medical information

6. YOUR SUMMARY CARE RECORD

Your summary care record is an electronic record of your healthcare history (and other relevant personal information) held on a national healthcare records database provided and facilitated by NHS England.

This record may be shared with other healthcare professionals and additions to this record may also be made by relevant healthcare professionals and organisations involved in your direct healthcare.

You may have the right to demand that this record is not shared with anyone who is not involved in the provision of your direct healthcare.

For further information visit the [SCR Website](#) or [Your health and care records](#), if you choose to opt out of the scheme, then you will need to complete the [opt-out form](#) and post it to the surgery.

If you do choose to opt out, you can still consent to your data being used for specific purposes. However, if you are happy with this use of information you do not need to do anything. You may however change your choice at any time.

7. WHO WE MAY PROVIDE YOUR PERSONAL INFORMATION TO, AND WHY

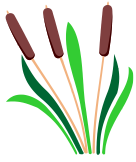
Whenever you use a health or care service, such as attending Accident & Emergency or using Community Care Services, important information about you is collected to help ensure you get the best possible care and treatment.

This information may be passed to other approved organisations where there is a legal basis, to help with planning services, improving care, research into developing new treatments and preventing illness.

All of this helps in providing better care to you and your family and future generations.

However, as explained in this privacy notice, confidential information about your health and care is only used in this way where allowed by law and would never be used for any other purpose without your clear and explicit consent.

We may pass your personal information on to the following people or organisations, because these organisations may require your information to assist them in the provision of your direct healthcare needs. It may therefore be important for them to be able to access your information in order to ensure they can properly deliver their services to you:

- A. Hospital professionals (such as doctors, consultants, nurses, etc.);
- B. Other GPs/doctors;
- C. Pharmacists;
- D. Nurses, paramedics, physiotherapists and other healthcare professionals;
- E. Dentists;
- F. Any other person that is involved in providing services related to your general healthcare, including Mental Health Professionals, Care Navigators, Pharmacists, Social Prescribers

8. OTHERS WHO WE PROVIDE YOUR INFORMATION TO

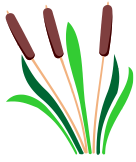
- A. Commissioners;
- B. Clinical Commissioning Groups;
- C. Local authorities;
- D. Community health services, including CHIE (see below)
- E. For the purposes of complying with the law, e.g. police, solicitors, courts, insurance companies;
- F. Anyone you have given your consent to, to view or receive your record, or parts of your record.

Please note: If you give another person or organisation consent to access your record we will need to contact you to verify your consent before we release that record.

In addition, it is also very important that you understand and are clear on what aspects of your record and how much of it you give consent to be disclosed.

Once your confidential information has left our premises the Bosmere Medical Practice ceases to act as Data Controller for the released information, and we can hence no longer be held responsible for the loss or misuse of this confidential information.

Care and Health Information Exchange (CHIE) – formerly known as the Hampshire Health Record

CHIE is a clinical and care service supplied by the South, Central and West Commissioning Support Unit (SCW) using health and care data to support treatment and care of patients by doctors, nurses, pharmacists, social workers and other professionals involved in delivering NHS or local authority commissioned services. This is designed to support direct care to patients.

The **legal basis** used by CHIE for processing data for patient care is:

- It is in the interest of the patient that the treatment they receive is safe, and safe treatment requires knowledge of the patient's medical history.
- Sharing is required under a number of pieces of UK legislation.

and the '**Special Category condition**' is:

- The provision of health or social care or treatment.

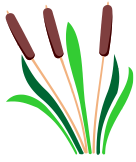
Extended Access:

We provide extended access services to our patients which means you can access medical services outside of our normal working hours. In order to provide you with this service, we have formal arrangements in place with the Clinical Commissioning Group and with other practices whereby certain key "**hub**" practices offer this service on our behalf for you as a patient to access outside of our opening hours. This means, those key "**hub**" practices will have to have access to your medical records to be able to offer you the service.

Please note to ensure that those practices comply with the law and to protect the use of your information, we have very robust data sharing agreements and other clear arrangements in place to ensure your data is always protected and used for those purposes only.

Hub practices are currently based at the Waterlooville Health Centre, Portchester Health Centre and the Swan Surgery in Petersfield.

The clinical commissioning group at times extracts medical information about you, but the information we pass to them via our computer systems **cannot identify you to them**.

This information only refers to you by way of a code that only your practice can identify (it is pseudo-anonymised).

This therefore protects you from anyone who may have access to this information at the Clinical Commissioning Group from **ever** identifying you as a result of seeing the medical information and we will **never** give them the information that would enable them to do this.

Care Quality Commission (CQC):

The CQC has powers under the Health and Social Care Act 2008 to access and use information where they consider it necessary to carry out their functions as a regulator. Where possible inspectors should explain why they are asking to look at certain records. They will consider any concerns and objections raised to them, and whether they can achieve CQC's purpose by accessing the records of someone else. However, the CQC relies on its legal powers to access information rather than consent, therefore may use its powers to access records even in cases where objections have been raised.

9. "PSEUDONYMISED" AND ANONYMISED INFORMATION

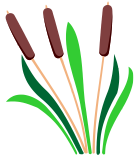
Care and Health Information Analytics (CHIA)

CHIA is a database used for analysing trends in population health in order to identify better ways of treating patients. This is called 'Secondary Processing'.

CHIA is a physically separate database, which receives some data from CHIE. The data on CHIA is 'pseudonymised', which means that all patient identifiers on CHIA are removed.

It is not possible to identify any patient by looking at the 'pseudonymised' data on the CHIA database, but even so, only a small number of South Central West Commissioning Support Unit (SCW) staff has access to CHIA and these people do not have access to CHIE.

SCW acts as a Data Processor and is responsible for processing personal data on behalf of the Data Controllers (GP Surgeries and other organisations supplying data). SCW has Data Sharing Agreements with all these Data Controllers.

Sometimes we may provide information about you in an anonymised form. If we do so, then none of the information we provide to any other party will identify you as an individual and cannot be traced back to you.

Clinical Practice Research Datalink (CPRD) – anonymised data only

The Clinical Practice Research Datalink (CPRD) is a governmental, not-for-profit research service, jointly funded by the NHS National Institute for Health Research (NIHR) and the [Medicines and Healthcare products Regulatory Agency \(MHRA\)](#), a part of the Department of Health.

The CPRD has been providing anonymised primary care records for public health research since 1987.

Research using CPRD data has resulted in over 1,700 publications which have led to improvements in drug safety, best practice and clinical guidelines. Examples include confirming safety of MMR vaccine, informing NICE cancer guidance, safeguarding use of pertussis vaccine in pregnancy, influencing the management of hypertension in diabetics.

CPRD is now also using primary care data in clinical trials. Examples include the Decide study, a real world diabetes studies comparing a new therapy to standard of care, and randomised controlled trials on myocardial infarction and COPD patients.

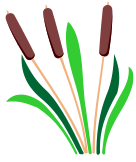
10. YOUR RIGHTS AS A PATIENT

The Law gives you certain rights to your personal and healthcare information that we hold, as set out below:

A. Access and Subject Access Requests

You have the right to see what information we hold about you and to request a copy of this information.

If you would like a copy of the information we hold about you please contact the practice. Once we have received your written consent we will provide this information free of charge,

however we have the right to make an administrative charge if the information requested is excessive, complex or repetitive.

We have one month to provide you with the information that you require. We would ask, therefore, that any requests you make are in writing, and it is made clear to us what and how much information you require.

B. Online Access

You may ask us if you wish to have online access to your medical record. However, there will be certain protocols that we have to follow in order to give you online access, including written consent and production of documents that prove your identity.

Please note that when we give you online access, the responsibility is yours to make sure that you keep your information safe and secure if you do not wish any third party to gain access.

C. Correction

We want to make sure that your personal information is accurate and up to date. You may ask us to correct any information you think is inaccurate. It is very important that you make sure you tell us if your contact details including your mobile phone number have changed.

D. Removal

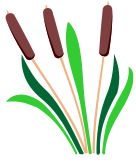
You have the right to ask for your information to be removed. However, if we require this information to assist us in providing you with appropriate medical services and diagnoses for your healthcare, then removal may not be possible.

E. Objection

We cannot share your information with anyone else for a purpose that is not directly related to your health, e.g. medical research, educational purposes, etc. We would ask you for your consent in order to do this; however, you have the right to request that your personal and healthcare information is not shared by the practice in this way. Please note the Anonymised Information section in this Privacy Notice.

F. Transfer

You have the right to request that your personal and/or healthcare information is transferred, in an electronic form (or other form), to another organisation, but we will require your clear consent to be able to do this.



G. Opt-Out

The national data opt-out allows a patient to choose that they do not want their confidential patient information to be used for purposes beyond their individual care and treatment, such as for planning and research.

11. THIRD PARTIES MENTIONED IN YOUR MEDICAL RECORD

Sometimes we record information about third parties mentioned by you to us during any consultation. We are under an obligation to make sure that we also protect that third party's rights as an individual and to ensure that references to them which may breach their rights to confidentiality are removed before we send any information to any other party including you. This does not apply to the names of health care professionals or our staff members but includes the names of spouses, partners and other family members.

12. HOW WE USE THE INFORMATION ABOUT YOU

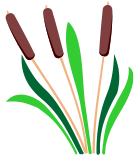
We use your personal and healthcare information in the following ways:

- A. when we need to speak to, or contact other doctors, consultants, nurses or any other medical/healthcare professional or organisation during the course of your diagnosis or treatment or ongoing healthcare;
- B. when we are required by law to hand over your information to any other organisation, such as the police, by court order, solicitors, immigration enforcement or Section 47 Child Protection enquiries.

We will never pass on your personal information to anyone else who does not need it, or has no right to it, unless you give us clear consent to do so.

13. LEGAL JUSTIFICATION FOR COLLECTING AND USING YOUR INFORMATION

The Law says we need a **legal basis** to handle your personal and healthcare information.

CONTRACT: We have a contract with NHS England to deliver healthcare services to you. This contract provides that we are under a legal obligation to ensure that we deliver medical and healthcare services to the public.

CONSENT: Sometimes we also rely on the fact that you give us consent to use your personal and healthcare information so that we can take care of your healthcare needs.

Please note that you have the right to withdraw consent at any time if you no longer wish to receive services from us.

NECESSARY CARE: Providing you with the appropriate healthcare, where necessary. The Law refers to this as 'protecting your vital interests' where you may be in a position not to be able to consent.

LAW: Sometimes the Law obliges us to provide your information to an organisation (see above).

14. SPECIAL CATEGORIES

The Law states that personal information about your health falls into a special category of information because it is very sensitive. Reasons that may entitle us to use and process your information may be as follows:

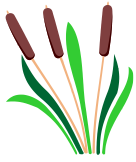
CONSENT: When you have given us valid consent;

PROVIDING YOU WITH MEDICAL CARE: Where we need your information to provide you with medical and healthcare services

VITAL INTEREST: If you are incapable of giving consent, and we have to use your information to protect your vital interests (e.g. if you have had an accident and you need emergency treatment);

PUBLIC INTEREST: Where we may need to handle your personal information when it is considered to be in the public interest. For example, when there is an outbreak of a specific disease and we need to contact you for treatment, or we need to pass your information to relevant organisations to ensure you receive specialist advice and/or treatment;

DEFENDING A CLAIM: If we need your information to defend a legal claim against us by you, or by another party;



15. HOW LONG WE KEEP YOUR PERSONAL INFORMATION

We carefully consider any personal information that we store about you, and we will not keep your information for longer than is necessary for the purposes as set out in this Privacy Notice.

All records are kept according to the NHS Records Management Code of Practice 2021 which determines our retention periods. <https://transform.england.nhs.uk/information-governance/guidance/records-management-code/>

The practice remains data controller for the records of patients registered with them after their death.

Please also note that our duty of confidentiality to a patient also continues after their death.

16. UNDER 16s

There is a separate (simplified and shorter) privacy notice for patients under the age of 16, a copy of which may be obtained on request.

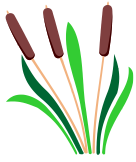

We take the security of your information very seriously and we do everything we can to ensure that your information is always protected and secure. We regularly update our processes and systems and we also ensure that our staff is properly trained. We also carry out assessments and audits of the information that we hold about you and make sure that if we provide any other services, we carry out proper assessments and security reviews.

All GP NHS health records are kept electronically. Our GP database is hosted by EMIS Healthcare Ltd, who is acting as Data Processor, and all information stored on their secure servers is protected by appropriate security with access being restricted to authorised personnel only.

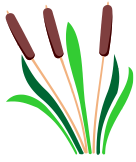
With effect from 10th June 2019, EMIS has been storing your practice's EMIS Web data in a highly secure, third party cloud hosted environment, namely Amazon Web Services ("AWS").

The data will remain in the UK at all times and will be fully encrypted both in transit and at rest. In doing this, there will be no change to the control of access to your data and the hosted service provider will not have any access to the decryption keys. AWS is one of the world's largest cloud companies, already supporting numerous public sector clients (including the NHS), and it offers the very highest levels of security and support.

22. TEXT MESSAGING AND CONTACTING YOU

Because we are obliged to protect any confidential information we hold about you and we take this very seriously, it is imperative that you let us know immediately if you change any of your contact details.

We may contact you using SMS texting to your mobile phone in the event that we need to notify you about appointments and other services that we provide to you involving your direct care, therefore you must ensure that we have your up to date details. This is to ensure we can be certain that we are actually contacting you and not another person.

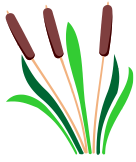

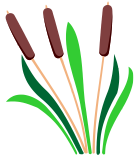

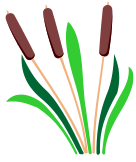

Summary Care Records	<p>Purpose – During the Covid19 pandemic practices have been told to share details of patients’ personal confidential and special category data onto the summary care record. The NHS in England uses a national electronic record called the Summary Care Record (SCR) to support patient care. It contains key information from your GP record. Your SCR provides authorised healthcare staff with faster, secure access to essential information about you in an emergency or when you need unplanned care, where such information would otherwise be unavailable.</p> <p>Legal Basis – Direct Care</p> <p>The relevant COPI notice states that its purpose: “...is to require organisations to process confidential patient information for the purposes set out in Regulation 3(1) of COPI to support the Secretary of State’s response to Covid-19 (Covid-19 Purpose). “Processing” for these purposes is defined in Regulation 3(2) and includes dissemination of confidential patient information to persons and organisations permitted to process confidential patient information under Regulation 3(3) of COPI.”</p> <p>Full details of the Summary Care Record supplementary privacy notice can be found here</p> <p>Patients have the right to opt out of having their information shared with the SCR by completion of the form which can be downloaded here and returned to the practice. Please note that by opting out of having your information shared with the Summary Care Record could result in a delay care that may be required in an emergency.</p> <p>Processor – NHS England and NHS Digital via GP connect</p>
CHIE	<p>Purpose – To provide Healthcare Professionals with complete, accurate and up to date information. 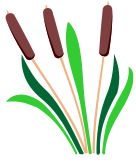

This includes names, initials, addresses, dates of birth and postcodes. NHS numbers are encrypted in the extract and cannot be read. This process is called 'pseudonymisation'. This subset of data does not include information typed in by hand, so there is no possibility of it containing references to family members or other people. It contains only coded entries for things like allergies and prescribed drugs. It is not possible to identify any patient by looking at the 'pseudonymised' data on the CHIA database. People who have access to CHIA do not have access to CHIE. Data in CHIA is used to plan how health and care services will be delivered in future, based on what types of diseases are being recorded and how many are being referred to hospital etc. Data is also used to help research into new treatments for diseases.</p> <p>Legal basis – You can opt out of this service</p> <p>Data processor – NHS SCW</p>
General Practice Extraction Service (GPES)	<p>Purpose : The General Practice Extraction Service (GPES) collects information for a wide range of purposes including providing GP payments for services they deliver, such as immunisations. 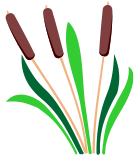

<p>Medication/Prescribing</p>	<p>Purpose : Prescriptions containing personal identifiable and health data will be shared with chemists/pharmacies, in order to provide patients with essential medication or treatment as their health needs dictate. This process is achieved either by face to face contact with the patient or electronically. 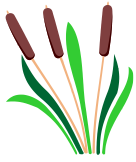

<p>Risk Stratification</p>	<p>Purpose – Risk stratification is a process for identifying and managing patients who are at high risk of emergency hospital admission.</p> <p>Risk stratification tools use various combinations of historic information about patients, for example, age, gender, diagnoses and patterns of hospital attendance and admission and primary care data collected from GP practice record systems.</p> <p>GPs will be able to identify which of their patients are at risk in order to offer a preventative service to them.</p> <p>Legal Basis - Risk stratification has been approved by the Secretary of State, through the Confidentiality Advisory Group of the Health Research Authority</p> <p>NHS England encourages GPs to use risk stratification tools as part of their local strategies for supporting patients with long-term conditions and to help and prevent avoidable hospital admissions and to promote quality improvement in GP practices.</p> <p>Data Processors – NHS South, Central and West Commissioning Support Unit (CSU) to assist us with providing Risk Stratification tools.</p> <p>Data Processing activities for Risk Stratification – The GP practice instructs its GP IT system supplier to provide primary care data identifiable by your NHS Number.</p> <p>Opting Out - If you do not wish information about you to be included in our risk stratification programme, please contact the GP Practice. 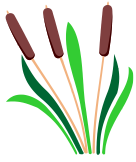

<p>Quality monitoring, concerns and serious incidents</p>	<p>Purpose – We need to ensure that the health services you receive are safe, effective and of excellent quality. Sometimes concerns are raised about the care provided or an incident has happened that we need to investigate. You may not have made a complaint to us directly but the health care professional looking after you may decide that we need to know in order to help make improvements.</p> <p>Legal Basis – The health care professional raising the concern or reporting the incident should make every attempt to talk to you about this and gain your consent to share information about you with us. Sometimes they can do this without telling us who you are. We have a statutory duty under the Health and Social Care Act 2012, Part 1, Section 26, in securing continuous improvement in the quality of services provided.</p> <p>Data processor – We share your information with health care professionals that may include details of the care you have received and any concerns about that care. In order to look into these concerns we may need to talk to other organisations such as Fareham & Gosport and SE Hants CCG as well as other Public bodies and Government agencies such as NHS Improvement, the Care Quality Commission, NHS England as well as the providers of your care.</p>
<p>Commissioning, planning, contract monitoring and evaluation</p>	<p>Purpose – We share aggregated, anonymous, patient data about services we have provided.</p> <p>Legal Basis - Our legal basis for collecting and processing information for this purpose is statutory. We set our reporting requirements as part of our contracts with NHS service providers and do not ask them to give us identifiable data about you.</p> <p>If patient level data was required for clarity and extensive evaluation of a service, consent will be gained for the surgery to share this information.</p> <p>Data Processor – Various organisations, CCG, third party organisations commissioned by the NHS to perform actuarial services, NHS England</p> <p>eConsult – anonymised aggregated numbers of contacts are shared for the online consultation tool.</p>
